

## GUIDELINES

- The LITDA Scholarship Committee sets the policies and makes the selections based upon high scholastic standards.
- Scholarships will be awarded to individuals who complete the Automotive Service Excellence (ASE) program. The recipient must meet requirements of the National Institute for Automotive Service Excellence.
- If requested, the applicant will make a personal appearance before the scholarship committee.
- Selected recipients may receive up to \$150 reimbursement per certification.
- Individuals are limited to up to two (2) \$150 reimbursement scholarships annually.
- The LITDA Scholarship Committee has the authority to award up to \$2,000 in ASE Scholarships annually.

## REQUIREMENTS

- Applicant must be employed by an LITDA member company.
- Two (2) ways to apply:
  - ◇ Before taking the ASE course you may apply for the scholarship. If selected, the scholarship will awarded after proof of successful completion/certification is submitted to LITDA within thirty (30) days of completion.
  - ◇ After taking the ASE course you may apply within thirty (30) days of successfully completing the course. Proof of successful completion/certification must be submitted with application and supporting documents.
- Application must be submitted and ASE Test Prep & Training must be successfully completed with in the same \*LITDA fiscal year. If the applicant/recipient does not complete the course within the same fiscal year, the applicant/recipient must reapply.

\*LITDA fiscal year: November 1—October 31
